Reverend Doctor Tony Michael Fulbright, Sr., 84, passed away peacefully on September 11, 2023, in the care of Robin Johnson Hospice House, Dallas, NC. Tony was the son of the late James C. and Virginia Fulbright of Lowell, NC.

On May 30, 1956, after graduation from Lowell High School, Tony enlisted in the United States Air Force, then in November 1956 married his high school sweetheart Gayle Waldrop Fulbright. Over the next twenty-two years they welcomed 4 children as they spent time on Air Force Bases

# ARTICLES OF INCORPORATION of GREATER CLEVELAND COUNTY BAPTIST ASSOCIATION, INC. A NONPROFIT CORPORATION

We, the undersigned natural persons of the age of eighteen or more, acting as incorporators for the purpose of creating a nonprofit corporation under the laws of the State of North Carolina, as contained in Chapter 55A of the General Statutes of North Carolina, entitled "Nonprofit Corporation Act," and the several amendments thereto, do hereby set forth:

## **ARTICLE 1 - NAME**

The name of the corporation is GREATER CLEVELAND COUNTY BAPTIST ASSOCIATION, INC, and shall be located in Cleveland County, Shelby, North Carolina.

## **ARTICLE 11 - DURATION**

The period of duration of the corporation shall be perpetual.

## **ARTICLE III - PURPOSE**

- **A.** The purpose of the Greater Cleveland County Baptist Association, Inc., is to unite congregations in effective missions and ministries.
- **B.** In furtherance of its purposes, and to the extent necessary to carry out such purposes, the Corporation:
  - 1. Shall have all the powers given to and possessed by a North Carolina Corporation organized under the North Carolina Nonprofit Corporation Act.
  - 2. May engage in any lawful activity within the purposes for which the corporation may be organized which are incidental to and in furtherance of the exempt purposes of the corporation.
- C. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes as set forth in the Articles.
- D. The purposes for which the Greater Cleveland County Baptist Association is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- **E.** No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not

permitted to be carried on [a] by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future U.S. Internal Revenue Law) or [b] by any corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future U.S. Internal Revenue Law).

## **ARTICLE IV - GOVERNMENT**

The government of this incorporated association shall be by elected representatives, known as messengers, from the member churches, meeting two times annually, or at such other times as called in accordance with the By-laws of the incorporated association, and, in the interim, by the Leadership Team of the incorporated association. Final authority is vested in the association as to all matters of business, finance, and programs. The members of the governing body shall have authority to adopt and amend By-laws, approve budgets, and to employ staff to direct or assist in directing the purposes of this incorporated association.

## **ARTICLE V - OFFICERS**

The officers of this incorporated association shall be the officers set forth in the By-laws.

### **ARTICLE VI - MEMBERSHIP**

The corporation shall have one class of members as provided by the By-laws, members being the total of all members of the churches affiliated voluntarily with the incorporated association. Membership of the member churches shall be accepted by majority vote of the association at a regular semi-annual session of the incorporated association.

### **ARTICLE VII - DIRECTORS**

The Leadership Team, as established by the By-laws, shall be and constitute the directors of the corporation, having such powers as are provided by law and the By-laws.

## **ARTICLE VIII - INITIAL DIRECTORS**

The initial directors shall be the twenty (20) members of the existing Executive Committee, and their terms shall be the same as the Executive Committee of the Kings Mountain Baptist Association of Shelby, North Carolina, whose names and addresses are as follows:

## ARTICLE IX - DISSOLUTION

Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for religious purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future U.S. Internal Revenue Law), as the board of directors shall determine. Any such assets not so disposed of shall be disbursed by the Superior Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

## **ARTICLE X - REGISTERED OFFICE AND AGENT**

The address of the initial registered office and principal office of the

corporation in North Carolina is 1175 Wyke Road, Shelby, Cleveland County, North Carolina 28150, and the initial registered agent of the corporation is Leland A. Kerr.

## **ARTICLE XI - INCORPORATORS**

## **ARTICLE XII - AMENDMENTS**

Amendments to these Articles of Incorporation may be made at any session of the Association upon the affirmative vote of two-thirds (2/3) of the voting members present. Proposed changes must be presented to the Association on the first day and voted upon by standing vote of the Association on the last day. It is recommended that all proposed changes first be submitted to the By-laws Committee.

## BY-LAWS OF THE GREATER CLEVELAND COUNTY BAPTIST ASSOCIATION, INC.

Also referred to as the Association, GCCBA, or Greater Cleveland County Baptist Association

## **BY-LAW I MEMBERSHIP**

**Section 1:** The Association shall be composed of cooperating Baptist churches in the area of the Association.

**Section 2:** Churches desiring membership in the Association shall apply to the Business Affairs Team. Application should include:

- (1) Formal action by the group seeking admission reflecting that seventy-five percent (75%) of those voting expresses their intent to cooperate.
- (2) A written statement reflecting their beliefs and practices.
- (3) A written statement that expresses their intent to cooperate.
- (4) A willingness to meet with the Business Affairs Team to discuss other items of mutual interest to both parties.

The Business Affairs Team should be sensitive to groups seeking its services and be willing to present a statement of Baptist belief and practice and what it means to cooperate with the churches in the Association in a world-wide mission program. If recommended by the Business Affairs Team and approved by the Leadership Team, a newly established mission or church shall agree to come under the watch care of the Association for a minimum of one (1) year. A mission or church which is already established shall agree to come under the watch care of the Association for a minimum of six (6) months. Membership within the Association shall be determined by vote of the Association at any biannual meeting. Churches under the watch care shall be entitled to all rights and privileges of the Association except their members shall not hold office nor vote.

**Section 3:** The Association shall be the sole judge of its membership and may receive churches, or reject churches, according to its By-Laws. Member churches may also withdraw as they desire, and if requested, the Association Leadership Team may grant letters of recommendation to other like associations.

## **BY-LAW II MEETINGS**

**Section 1.** The Association shall meet biannually. It shall convene on the

Monday following the fourth Sunday in April and Monday and Tuesday following the fourth Sunday in October.

**Section 2.** Special meetings may be called by the Moderator or Leadership Team, provided two (2) weeks notice is given to all affiliated churches.

**Section 3.** Each church shall elect annually, in addition to the pastor, two (2) messengers to the meetings of the Association for each fifty (50) members of the church, provided each church shall not have fewer

than three (3) nor more than ten (10) messengers. These ALONG WITH ALL ASSOCIATIONAL OFFICERS, shall constitute the voting body of the Association. The names of the messengers printed in the minutes shall include only those in attendance and registering at the Associational meetings.

**Section 4.** Items of Business to be presented from the floor must be submitted in writing to the Associational Office at least 30 days prior to the first session of the Biannual Meeting.

## **BY-LAW III PARLIAMENTARY RULES**

Robert's Rules of Order shall be followed as the Association's rules for conducting its deliberative assemblies, unless the Association prescribes otherwise.

### **BY-LAW IV ASSOCIATION YEAR**

The Association Year shall begin January 1 and close December 31.

## **BY-LAW V AUTHORITY**

Each church in this Association is independent and sovereign in its own affairs, and the Association has no authority over the churches.

## **BY-LAW VI OFFICERS AND THEIR ELECTIONS**

**Section 1:** The officers of the Association shall be the Moderator, Vice-Moderator, Clerk-Treasurer, Assistant Clerk-Treasurer, Historian, Sunday School Team Leader, Discipleship Training Team Leader, Music Team Leader, Men's Ministries Team Leader, Woman's Missionary Union Team Leader, Senior Adult Team Leader, Youth Team Leader, and Parliamentarian.

**Section 2:** The Moderator, Vice-Moderator, Clerk Treasurer, and Assistant Clerk-Treasurer shall be nominated by the Enlistment Team. The floor will be opened for additional nominations. This election will occur on the last day of the October biannual meeting. These officers will begin their terms of service on January 1.

**Section 3:** The newly elected Moderator, Vice Moderator, Clerk Treasurer, and Assistant Treasurer shall assume on January 1 all duties incumbent upon them relating to work of the associational year, along with all other officers.

**Section 4:** Any person having served two (2) terms as Moderator shall be ineligible for re-election for two years.

## **BY-LAW VII DUTIES OF OFFICERS**

**Section 1:** The Moderator shall preside over the meeting of the body and shall be the Chairperson of the Associational Leadership Team and be ex-officio (without voting privileges) member of all other teams.

**Section 2:** The Vice-Moderator shall preside in the absence, or at the pleasure, of the Moderator, and shall be the Vice-Chairman of the Leadership Team and Chairman of the Associational Council.

**Section 3:** The Clerk-Treasurer shall send annual report forms to the member churches at least a month before the Association's October

Biannual Meeting, distribute at that meeting copies of the digest of these reports, make an accurate record of the proceedings of the Association, supervise the printing and distributing of Minutes to the member churches, and keep on file copies of Minutes, records, and other documents of the Association. This officer shall inform all members elected to office or appointed to serve on teams of such action and shall receive and bank all funds of the Association in the name of the Association; disburse the same upon instructions from the Association, its Leadership Team, or as designated in the budget (no money is to be disbursed which is not included in the budget except upon recommendation of the Business Affairs Team to the Leadership Team or the Association in biannual session); render an accurate report of receipts and disbursements, distribute same at the biannual meetings, give a report at each Leadership Team and Business Affairs Team meeting, and keep books available and up-to-date for examination.

**Section 4:** The Assistant Clerk-Treasurer will serve in the absence of the Clerk-Treasurer or by request of the Clerk-Treasurer. The Assistant Clerk-Treasurer will also be authorized to sign checks for the Association.

**Section 5:** The Historian shall collect and preserve historical data on the Association and its churches and make a written report to each October Biannual Meeting of the Association.

**Section 6:** The Sunday School Team Leader shall cooperate with the Associational Missionary in promoting the work of the Sunday School. This officer shall attend the Associational Council meetings and offer creative plans that would promote this work.

The Associational Sunday School Team Leader should assist church leaders to be more effective in their responsibility. This should include:

- 1. Provide opportunities for fellowship and inspiration.
- 2. Interpret the Sunday School Program.
- 3. Train Sunday School leaders.
- Consult with Sunday School leaders concerning their program.
- 5. Provide organization and leadership for cooperative work among the churches.

The Sunday School Team Leader shall make a written report to the October Biannual Meeting of the Association.

**Section 7:** The Discipleship Training Team Leader shall cooperate with the Associational Missionary in promoting the work of Discipleship Training. This officer shall attend Associational Council meetings, maintain the on-going work of Discipleship Training at all times, and make a written report to the October Biannual Meeting of the Association.

**Section 8:** The Music Team Leader shall provide leadership for the Association in biannual sessions and, when requested, at other times during the year. This officer shall attend the Associational Council meetings and offer creative plans that would promote the work. The Music Team Leader shall encourage music growth in the churches roughout the year and shall make a written report to the October

Biannual Meeting.

**Section 9:** The Men's Ministries Team Leader shall cooperate with the Associational Missionary in promoting the work of men and boys in the churches. This officer shall attend the Associational Council meetings and offer creative plans to promote the development of men and boys in an awareness of world mission needs. The Men's Ministries Team Leader shall make a written report to the October Biannual Meeting of the Association.

**Section 10:** The Woman's Missionary Union Team Leader serves on the Associational Council of the Association and works with the Associational Missionary; leads the WMU Council; confers with our associational WMU officers and assists them in their work; leads in providing opportunities for leaders and members of their church WMUs to have fellowship and receive inspiration concerning their mutual mission task; leads in interpreting the WMU program to church leaders; leads in training church WMU workers and members; consults with church leaders concerning initiation of WMU work and the improvement of existing work; presides at and plans for associational meeting; leads in Associational WMU annual planning; leads in discovering mission action needs and in coordinating the work being done; reports progress of WMU work to the Association; and serves as contact between the Association and state WMU. The Woman's The Woman's Missionary Union Team Leader shall make a written report to the October Biannual Meeting of the Association.

**Section 11:** The Youth Ministry Team Leader shall, under the supervision of the Associational Missionary, give leadership to the Youth Ministry Team and serve on the Associational Council. The Youth Team Leader shall give a written report to the October Biannual Meeting of the Association.

**Section 12:** The Senior Adult Leader shall, under the supervision of the Associational Missionary, give leadership to the Senior Adult Ministry Team and serve on the Associational Council. The Senior Adult Leader shall give a written report to the October Biannual Meeting of the Association.

**Section 13:** The Team Leaders shall have the responsibility of securing their own team members that will assist them in their area of responsibility.

**Section 14:** The Parliamentarian shall be, at the biannual meetings of the Association, rule on all questions of parliamentary procedure which shall arise during the sessions. The Parliamentarian shall serve as a resource person to the churches and shall, upon request, advise and assist the churches on matters of parliamentary procedure.

**Section 15:** Vacancies occurring between biannual sessions shall be filled by the Associational Leadership Team, except the office of Moderator, in which case the Vice-Moderator shall automatically become Moderator.

## **BY-LAW VIII TEAMS**

**Section 1:** The Association shall have the following standing Teams:

Leadership, Business Affairs, and Enlistment. The members of the teams shall serve three years and are ineligible for re-election for one year.

- **Section 2:** The Enlistment Team shall submit their nominations for team members to the Biannual Meeting in October for election. Nominations shall be made for the following teams: Leadership, Business Affairs, and Enlistment.
- **Section 3:** The Enlistment Team shall submit their nominations for Associational Officers and Leadership to the Biannual Meeting in October for election.
- **Section 4:** The Enlistment Team shall submit their nominations for any Project Team to either the Leadership Team or a Biannual Meeting.

## **BY-LAW IX DUTIES OF TEAMS**

- **Section 1:** The Leadership Team will be composed of three members from each of the six groupings of churches within the Association. One shall be a layperson, and one from each group will be designated as the Group Leader.
- **A.** The six Group Leaders will form the Personnel Team and shall handle all personnel matters relating to the Associational staff. The

Personnel Team will maintain appropriate personnel policies and be responsible for securing and recommending to the Leadership Team Associational support staff when needs occur. They will also recommend salary and benefit proposals to the Business Affairs Team.

- **B.** The Leadership Team shall have the authority to act for the Association between Biannual Sessions of the Association. Ten members of the Leadership Team shall constitute a quorum in order to transact business on behalf of the Association.
- **C.** The Leadership Team shall give instructions to the Enlistment Team whenever a particular Project Team is needed to address a special need. Instructions may include such things as size and make-up of the team, a specific task, etc.
- **D.** The Leadership Team will prepare the agenda for the Biannual Meetings to be published in the *Beacon*. It shall rotate the place of meeting among the groups of churches.
- **E.** The Leadership Team will meet quarterly and other times as needed and be chaired by the Moderator of the Association. In his absence, it will be chaired by the Vice-Moderator.
- **Section 2:** The Business Affairs Team will be made up of two members from each of the six groupings of churches within the Association.
- **A.** The Business Affairs Team will have the responsibility of preparing and promoting the annual budget.
- **B.** It will handle all inquires concerning membership into the Association and make its recommendations to a Biannual Session of the Association.

- **C.** It will bring any resolution that needs to come before the Association.
- **D.** It will oversee the operation of the Associational office by providing adequate equipment and supplies. It will also oversee all property held by the Association and be responsible for proper maintenance.
- **E.** It will make recommendations to the Association concerning By-Law changes.
- **F.** The Business Affairs Team will have the financial records of the Greater Cleveland County Baptist Association, Inc. audited every third year.
- **G.** When it feels that additional approval is necessary, it may bring the matter in question to the Leadership Team or to the Association at a Biannual Meeting.
- **H.** The Business Affairs Team will meet as often as needed and will be chaired by the Vice-Moderator.
- **Section 3:** The Enlistment Team will be made up of two members from each of the six groupings of churches within the Association.
- **A.** The Enlistment Team will have the responsibility of nominating members for the Leadership Team, Business Affairs Team, and Enlistment Team and shall present its recommendations to the Fall Biannual Meeting.
- **B.** It will nominate the leadership of all organizations within the Association and present its recommendations to the Fall Biannual Meeting.
- **C.** It will select members of any special Project Team, the number of which will be determined by either the Leadership Team or the Enlistment Team itself, and will present its recommendations to either the Leadership Team or to a Biannual Meeting.
- **D.** The Enlistment Team will meet as often as needed and will be chaired by the Vice-Moderator.

### BY-LAW X ASSOCIATIONAL COUNCIL

The Associational Council will meet as often as is necessary in order to coordinate the programs and activities of the Associational organizations. Because of the make-up of its members, the Council will remain sensitive to the educational needs of our Association, as well as, the spiritual, physical, and emotional needs of the people of Cleveland County.

The Council will produce an Associational Calendar of Activities and be responsible for promoting those activities.

Whenever it feels it necessary, it may bring recommendations to the Leadership Team through the Vice-Moderator, who will serve as chairperson of the Council.

The Associational Council will be made up of at least the following

members: Sunday School Team Leader, Discipleship Team Leader, WMU Team Leader, Baptist Men Team Leader, Music Team Leader, Senior Adult Team Leader, Youth Team Leader, Ministers Conference President, Ministry Team Leader, Missions Team Leader, Hispanic/Language Missionary, and Vice-Moderator of the Association but may add additional members whenever the Council feels it is necessary in order to have adequate representation from all organizations within the Association.

### BY-LAW XI ASSOCIATIONAL MISSIONARY

When without an Associational Missionary, the Associational Leadership Team shall be responsible for the appointment of a Search Team to seek a person to serve as Associational Missionary and recommend such person to the Leadership Team. His selection shall be upon the recommendation of the Leadership Team and on vote by the Association at a biannual meeting, or by a called meeting of the Association. His time of office shall continue until terminated by mutual consent or request of either party. He shall be a member of all teams and organizations of the Association in a serving and advisory capacity. His duties will be in accordance with the job description at the time of his call.

### BY-LAW XII MINISTRY TEAM LEADER

**Section 1:** Employment -- The Ministry Team Leader shall be employed by the Association. The employee shall be elected to work until the Association ceases the tenure of service or the employee resigns. The Ministry Team Leader shall work under the supervision of the Associational Missionary and in compliance with the job description provided by the Association.

**Section 2:** Basic Function -- The basic functions are to promote a program to meet the spiritual, educational, emotional and physical needs of the people within the Association.

**Section 3:** The Ministry Team Leader shall be a member of the Associational Council and of the Leadership Team.

## **BY-LAW XII MISSIONS TEAM LEADER**

**Section 1:** Employment -- The Missions Team Leader shall be employed by the Association. The employee shall be elected to work until the Association ceases the tenure of service or the employee resigns. The Missions Team Leader shall work under the supervision of the Associational Missionary in compliance with the job description provided by the Association.

**Section 2:** Basic Function -- The basic function is to assist the churches in the Association in any and every mission endeavor that can be addressed by the churches in our Association and to assist the churches in discovering the mission opportunities in both Cleveland County and beyond.

**Section 3:** The Missions Team Leader shall be a member of the Associational Council and Leadership Team.

## **BY-LAW XIV HISPANIC/LANGUAGE MISSIONARY**

**Section 1:** Employment -- The Hispanic/Language Missionary shall be employed by the Association. The employee shall be elected to work until the Association ceases the tenure of service or the employee resigns. The Hispanic/Language Missionary shall work under the supervision of the Associational Missionary in compliance with the job description provided by the Association.

**Section 2:** Basic Function -- The basic function is to seek out areas in Cleveland County which need an established work among Hispanics and give leadership in establishing such work, while remaining sensitive to the presence of other language groups and determining how and when work among such groups should begin.

**Section 3:** The Hispanic/Language Missionary shall be a member of the Associational Council and the Leadership Team.

### **BY-LAW XV AMENDMENTS**

Proposed amendments to the By-Laws must be publicized in the Association's monthly publication at least 30 days before being considered at a session of the biannual meetings, where they may be adopted by a majority of the messengers present and voting.

## **BY-LAW XVI DEFINE PROCEDURE**

**Section 1:** The business session of the Association shall be opened and closed with prayer.

**Section 2:** Every report, resolution, or amendment offered to the Association shall be submitted in writing if requested by the Moderator.

**Section 3:** No person shall speak more than twice on the same subject except by permission of the Association.

**Section 4:** A simple majority of elected messengers attending shall be sufficient to conduct business at Biannual Meetings.

**Section 5:** Unless the Association decides otherwise, biannual meetings shall be held on a rotating basis with a church or churches in each of the six (6) Associational Groups as follows: Polkville, Lattimore, Shelby, Kings Mountain, Grover, and Waco.

### BY-LAW XVII THE CONFESSION OF FAITH

The Baptist Faith and Message as revised and adopted by the Southern Baptist Convention in June 1998 shall be the Confession of Faith of the Association.

## Spring Biannual Meeting Proceedings Monday April 24 – Shelby Mission Camp

- 1. 59 Messengers and 12 non-messengers for a total of 71 people gathered at The Shelby Mission Camp for the 25<sup>th</sup> Spring Biannual Session of the Greater Cleveland County Baptist Association.
- 2. Rev. Maggie Andre, minister of music for Eastside Shelby, led in worship. Due to technical difficulties, she asked the congregation to look up the lyrics to Holy, Holy, Holy. She joked that smart phones could be used for good. The congregation joined together in Holy, Holy, Holy. Mrs. Andre, then, shared a song that she had written two weeks prior entitled You Are Good. Rev. Andre stated that after celebrating Easter, this song reminds us how good God is and of our need to return to Him. She also shared that her Facebook page has other songs she has written.
- Reverend Mike Shumate, pastor of Union Baptist Church and moderator of the GCCBA, congratulated Reverend Jason Ballard, associational missionary strategist to the GCCBA, on his one year anniversary of working at the GCCBA. He then called the meeting into order.
- 4. Reverend Robbie Alexander, director of Shelby Mission Camp, thanked everyone for coming to the meeting. He stated that he loves the churches of GCCBA and would love to get churches in volved in the work of the camp. He was holding his young daughter, Reagan and stated that she is the chief operator of snacks. He stated that if he looked like he had been crawling under

- a house, it is because he was. He stated because of the work of the camp, a homeowner will be able to take a shower in his house for the first time in two years.
- 5. Reverend Randy Willis, pastor at Lawndale Baptist Church, shared the Great Commission-Matthew 28:19. He thanked Rev. Jason Ballard, Mrs. Katie Harris, and Mrs. Nicole Mosley for always being inspired and always answering questions. We are united together making disciples. Authority teaches the Gospel. He directed the congregation to the promise from God that He will be with us. He stated that it is important for believers to tell, preach, pray, and support. He reminded the congregation to be Mission Minded. He then led in prayer.
- 6. Rev. Jason Ballard came to recognize any new pastors and staff. He introduced Rev. Randy Willis, Lawndale. He asked everyone to fill out yellow cards and pass them to the ends of the aisle.
- 7. Rev. Jason Ballard talked about the Associational Bible Drill that was held at Mt Sinai. Students shared in their memorization of Scripture and other bible drills. At that time, he also saw the speech tournament. He asked Miss Annabelle Hamrick if she would share the speech that she had written. She is a senior at Crest High School and will be attending Charleston Southern University in the fall. He recognized Annabelle.
- 8. Miss Annabelle Hamrick came to deliver her speech entitled, "The Greatest Story Ever Told." She said if she cries, that it is okay because it is normal. Rev. Ballard thanked Miss Hamrick and stated that he knows God's hand is on her life.
- Miss Debby Wease, treasurer for GCCBA, thanked all the churches for their support and she gave the cash flow report. She stated that she is thankful for the support and enabling the Association to unite the congregations together in effective missions and ministry.
- 10. Rev. Maggie Andre from Eastside, Shelby led the congregation in "Tell Me the Story of Jesus". She asked everyone to look up the lyrics on hymnary.org. She said that Miss Annabelle Hamrick had shared a beautiful testimony of the story of Jesus.
- 11. Mr. Joey Hamrick came to introduce Rev. Michael Woods and reminded everyone that Miss Annabelle Hamrick is his niece and that he is grateful she is telling everyone about Jesus. He said that in December 2019 the Cleveland County Rescue Mission's executive director resigned. So, at the January 2020 Board Meeting the board just began to pray. The prayers led to Rev. Michael Woods, Director at Asheville Western Carolina Rescue Mission. They met for 2 hours, and 20 minutes and he talked about what God is doing, not what they were doing. Rev. Woods came from Grover and went to Kings Mountain. They began to explore what a partnership with Western Carolina and Cleveland County would look like. They prayed

through that week even though he said he would never come back to Cleveland County. He came to the meeting and Rev. Woods said, "God told me to come home." We told him that he didn't have a voice unless he had a seat at the table, we invited him to our table to the Cleveland County Rescue Mission.

12. Rev. Michael Woods came to speak and said he was grateful to be here. He remembered that time Mr. Joey Hamrick spoke of when he was minding his own business. He thought he was good. But God promotes us in our busyness. He stated that he found out about CCRM 12 years ago when he met the former executive. He was happy God called someone. He met him, and he even sent down beds because he was super excited God wasn't calling him. God is funny. He said he left Cleveland County, and he didn't want to come back home. He said that he would sneak back to see his grandmother, and she passed at the age of 102. He said that she is the reason he is in the kingdom, because she would not stop praying. When he was growing up, he would wait to hear his name in his grandmother's prayers, then he would go out because he knew he was good. He stated that tonight he came because he needs us to see what God is doing at Cleveland County Rescue Mission. Women and children live at 1100 Buffalo Street. The Washington Street Building that CCRM owns is not suitable for 49 women and children. They have an overnight ministry to get people off the street. There is a six-month restoration program where they deal with trauma and are paired with a social worker. The goal is to get them to transition into housing. The mission provides hot meals every day. The Mission was able to purchase a 20,000 square foot building for men that has some of the identical programs. In the first 30 days, they receive one on one counseling and Christcentered classes. It is a blessing to see men's lives turning around. They have 8-12 men right now and can hold up to 24. There are 11 men that are working every day. They help the men with saving money and money management. From Dec 1st-March 31st, they run an emergency shelter for men. They had an average of 15-18 men but had room for 30 men. They make sure they are fed dinner and breakfast. It is very expensive, but praise the Lord, nine men gave their lives to the Lord and were baptized. The next project at the men's shelter is shared housing. At the facility on Julius Street, they are renovating the building to make 20-bedroom units. These men don't have credit, and it is hard to get housing, and some have criminal charges. They will share a kitchen, bathroom and living area. They will pay \$125 a week to live in a loving and safe atmosphere. At the Asheville Mission, we have chapel every Mon day at 9am for clients and staff. A lady came to Mr. Woods during chapel, who looked familiar, but he wasn't sure who she was, and she reminded him that he baptized her and her daughter a year and a half ago. She had gotten back with an abusive husband and needed to leave Shelby, so she came to Asheville to be safe. She told Pastor Michael; she reads her Bible every day and claimed that God is so good. Pastor Michael believes the Bible in its entirety, not just parts of it, and that is important. He read from 1 John 2 and Romans 12. There is so much going on today. He said brothers and

sisters we must be diligent in how we approach what is happening in our society. We need to love what is right. The world does not know true love. God is Love. The world attaches love to an emotion. Asheville is the bumper sticker city of the world, where many bumper stickers tell you what love is. This is spilling over to school. We are to react differently. The Church cannot conform to culture. He said that he believes in the Word. The culture should not be dictating the Kingdom of God, it should be vice versus. We are called out. He said he loves seeing people come to the Lord. There is a responsibility to help, they don't need to hear what is right and wrong from the culture. God gave Pastor Michael the vision in 2018 after a staff meeting, he wanted to help women with addiction because so many babies were being born addicted to opioids, heroin, and meth. In the year 2016, there were 400 babies born to addiction, that the state took into custody. Foster homes were full, and this was causing major problems. They had the space, so they spent the next 3 hours walking and praying. They met with the architect, and 2 days later had a drawing. The contractor gave an estimate of \$725,000 or more, and 5 days later they had \$500,000 to start building a Christ-centered facility. Jesus is the answer. It all belongs to Jesus. The Asheville Mission won a national award one year, and it was the first time a rescue mission had ever won. The Supreme Court will not get in the place of interpreting Scripture, but that is where their statement of belief comes from. We believe Biblical marriage is one man and one woman. A Trust wanted to give the Asheville Mission a large sum of money, but they were not willing to take Biblical marriage out of their statement that is posted on the website, because they believe the Bible. After arriving at CCRM, Pastor Michael understood that one of the fundings had a clause saying no religious instruction. He called Mr. Joey Hamrick who was the chairman of the board at the time and told him there was a problem. We were out of compliance, so Pastor Michael decided to make a ridiculous offering to get them out of the funding. They took the offer, but the lady that he was talking to called him back while she was in her car and thanked him for not being willing to bend from His beliefs just to have the money. Jesus is the answer and we do not let the culture influence us. It only takes common sense to know the difference between women/men, the culture is redefining. We know the difference between right and wrong. God has called us to fight. Love never fails, an unsaved culture can experience love through us. Love doesn't mean endorsing sin. and we don't debate over human sexuality. The Word of God is simple, He created male and female, in His image. He said he understands, prays for them and loves them, and doesn't give in to it. We have the Word of God. We help culture see the truth. It is not us against them. He wants them too. Pastor Michael got saved at age 16 in Earl. His neighbor invited him to a revival, and he thought this would be a good opportunity to see girls he hadn't seen before. He spotted somebody, and they spotted him. The choir was singing, it was hot, they were passing out fans. Rev. Rector came and he wrecked his life. The pastor stopped the choir, God told him that there is somebody here that God wants, so he looked around at everybody. The pastor said his

wife was on her deathbed, but she made him come. God says it's today, even while you were driving here in your car and you asked a guestion. Pastor Michael thought he was saved or he knew how to play saved. He was grateful for that moment. He wants everyone to know Jesus, drug addict, dealer, prostitute, pimp, trans, bi. God has called us to love them. He is not endorsing sin. He is not trying to make it okay. He believes the Word. He said he wants to be effective in the culture. He again recognized what a wonderful job Miss Annabelle Hamrick did, and he said he knew doors would be opened in her life. He is excited about her journey at Charleston Southern. He said he knows the basketball coach and introduced him to his wife. He said, "God has gifted you, Annabelle." He said that we know what it means when the preacher closes his Bible. He believes what God is doing is transformative. Someone needs help. We can house women and children. We want to partner; we need your help. We are currently \$150,000 under budget. We need volunteers for programs for men and women and VBS for kids. We need your help. The world will not fund what God is doing. Come and see. Thank You.

- 13. Rev. Jason Ballard, AMS, reminded us about our mission statement, we need to be effective in mission and ministry.
- Rev. Jason Ballard shared some ways to partner in upcoming events.

He thanked God for the faithful support toward the Baltimore partnership as such with Jeff Johnson and FBCKM. Baltimore is a great city to have dinner downtown, a night on the beach and the best crab cake you will ever eat! Rev. Brown thought he might sound like a travel agent instead of a church planter. He referenced Annie Armstrong and stated that he is a pastor because of Annie's visionary leadership. Annie was also born and buried in Baltimore. Rev. Brown talked about his community, in Baltimore, homelessness, addictions, and prostitution are some of things he sees in the outreach center. He said he was 48 years old when God said it was time to go and plant a church. He first was introduced to Graffiti Church in New York while visiting his

daughter. After meeting Rev. Taylor, he saw how the pastor loved people like Jesus did. Rev. Taylor asked if he would like to plant a church in Coney Island, and Rev. Brown thought that would be great, Nathan hotdogs! His wife wanted to pray about this move. God did not give the green light to plant at Coney Island. Charlie and Diane continued to pray. As the Lord spoke to Diane and He disciplined Charlie, they ended up in Baltimore in a tough neighborhood that is 97% African American in 2014. They were received with love and curiosity. They were able to purchase a 100 -year-old vacant building. God began His work at this center with Celebrate Recovery meeting in the building. This area is very challenging with high murders, youth violence, and opioid overdose. God has called us to love these people. He talked about Barry who buried his wife an alcoholic, and Reggie in and out of jail, who both have professed, confessed, and baptized. North Carolina Baptists have been faithful to support this mission with coming to help with sports camps, tutoring, and serving meals. The church feeds every Friday, because many just do not have enough. Charlie loves to share with the people in his community, Toshay got pregnant in seventh grade, but she stayed in school and finished and is now going to college, another one lost his adult son to an opioid overdose at 22 years old but then was saved by God. A Baptist pastor buys an abandoned liquor store that will add around 10,000 square feet that comes with a lot of projects. He has had a lot of support from North Carolina Baptists. They also have a missionary apartment. We are very thankful to be a part of this community and continue to get to share Jesus. Why did God send a 48-year-old pastor? Because this community needed some love. We love Baltimore and the churches that are in the city, and they are reaching a different community. Both Charlie and Diane are NAMB church planter missionary. He is thankful that there are more churches that are partnering, many of my new friends are beating addictions, and Celebrate Recovery is still sharing Jesus. We didn't just plant a church, but we planted our life!

Jason thanked everyone for taking time to be at the meeting and Pleasant City for being a great host. He asked us to especially remember Rev. Wayne Brazwell, pastor at Oak View who was on his way to the hospital and Rev. Harold Fite, pastor at Waco, who is in transition to his Heavenly home.

## Associational Mission Strategist Report—Fall 2023

I can't believe it's been a year since I last reported on the work of the GCCBA in our annual book of reports. Even though a lot has happened since then, it still seems like only last week, but in truth many things have been happening.

Following our 2022 Fall Biannual Meeting, we conducted the Greatest Treat Festival in the Shelby City Park and followed that up with our holiday traditions of the Pastor's Christmas dinner and the annual Toy Store event. I, along with the GCCBA "dream team" of Katie Harris and Nicole Mosley, look forward to these events again this fall. I hope your church can join us for the 2023 Greatest Treat Festival on October 29. I also hope your pastor can join us with their spouse on December 4<sup>th</sup>.

Last year, winter saw us launch our first ever, Restore Retreat Pastors and Spouses at Ridgecrest. It was an amazing time with 50 attendees and the outstanding leadership of Dr. Sandy Marks of the Baptist State Convention of NC as we examined the challenges of pastoral health and spent time encouraging and praying for each other. We look forward to an even larger crowd this coming February  $15^{\rm th}-17^{\rm th}$ , as we host the second annual Restore Retreat for Pastors and Spouses, and we hope that many of you will send your pastors and their spouses to this vital time of refreshing encouragement for ministry.

In April, we held our second Deacon and Leader Training event of my tenure here at the GCCBA and were excited to host Dr. Jeff Iorg of Gateway Seminary as he shared from his book, *The Case for Antioch*. Many were encouraged as we explored the challenge of being a New

Testament church in a modern world. I am excited to share that Dr. Iorg will be with us once again in April 2024 to share again in our Deacon and Leadership Training event.

As spring turned toward summer our attention moved toward new efforts to explore. In May, I was privileged to lead a small group of pastors to Baltimore, Maryland to explore a possible partnership with the Baltimore Baptist Association. It was an exciting trip as we got to see the impact that an association is making in a challenging city. We will welcome several representatives to our Fall Biannual Meeting this year who are church planters, pastors and leaders from Baltimore and I am excited to hear what God is doing to bring our hearts together as we search for strong partners in mission.

In fact, summer took on this same focus as we first launched a new weekend missions experience with our local partner, the Shelby Mission Camp. On the first weekend in June, 80+ participants from our churches joined us for Church Without Walls – a weekend missions experience that challenged participants to see themselves as missionaries in their everyday contexts and then sent them out to serve in local areas of need. We look forward to our second annual Church Without Walls event early next summer as we continue to develop opportunities for our churches to engage their members in missions.

Following Church Without Walls, the GCCBA took another bold step into mission partnerships by sending two teams into Hungary to lead English Speaking Bible Camps. These two teams spent a week teaching English and the Bible and interacting with a local church and pastor as we explored the call to the ends of the earth. I am excited to announce that we will return next July to serve in these same schools as we further the efforts of sharing the Gospel and supporting the local church. I hope many more can join as we expand our efforts into additional schools as we seek to join our partners Baptist on Mission and Hungarian Baptist Aid in planting churches in these secular cultures.

As summer turned to fall, we turned our attention to our Fall Deacon/ Leader training and welcomed Terry Long of the Baptist State Convention of NC to lead us into a deeper discussion of church revitalization at the "Church Health Checkup." I am still working through all the efforts of the many deacons and leaders who attended this hugely successful event and I can't thank each of you enough for your participation in this (even if we did run out of mashed potatoes.)

So, as we enter the time for another Fall Biannual meeting, I am encouraged by the new vision that has come out of our re-visioning teams work over the past year. As I shared recently with our leadership team – the new vision of the GCCBA is "to build and rebuild healthy churches" by resourcing and equipping our churches in 6 key areas that are at the heartbeat of what we do. Those six areas are Pastoral Health, Congregational Health, Mission Partnerships, Community Engagement, Ministry Support and Leadership Development. In the coming year, I will endeavor to not only unpack and explain these areas of emphasis, but we as a staff are developing our calendar and all our plans around this theme to strengthen the health of our churches.

**Eastside, Shelby:** Eastside is Partnering with five local Churches in building a Habitat House.

Polkville: Rodeo Polkville June 16-17, 2023 - funds are used to support mission efforts carried out by the church. There is also evangelism happening at the actual rodeo. This past year Don Sunshine and his team of evangelists helped coordinate this for the church. Monthly Clothing Closet for babies/preschoolers - is available every 3rd Saturday of the month to select available clothes as well as get diapers and wipes. Food Pantry -available during office hours and by appointment Operation Christmas Child - church packs boxes but also serves as a pickup site. Park Ministry—church runs the concession site at ballfield - has the opportunity to interact with community - funds help community outreach efforts as well as other mission and ministry efforts. Women At the Well - women's program in October 2022 for both church and community - serves as outreach to the community Participation in local Christmas parades - Casar and Polkville - gave out church invitations and did outreach Goodie bags for local businesses used this as platform to share about the church as well as reason for Christmas Neighborhood goodie bags - Went door to door handing out treat bags and invitations for church as well as church information.
